

Terms & Conditions – “Net-Work Partners Package” Prize Draw

This prize draw is promoted by England Netball, the Netball Super League (NSL), the All England Netball Association (“England Netball”, “we” or “us”), a company limited by guarantee (registered number 01698144) whose registered office is England Netball, SportPark, 3 Oakwood Drive, Loughborough, Leicestershire LE11 3QF.

Any references to “we”, “us” or “our” shall be taken as references to England Netball/NSL.
Any references to “you” or “your” shall be taken as references to any applicant for the prize draw.

By entering the prize draw, you are deemed to accept the following terms:

The Prize Draw

1. This prize draw opens at 00:00:00 BST on Wednesday, 1st April 2026 and closes at 23:59:59 BST on Tuesday, 5th May 2026.
2. The prize draw is open to UK residents only.
3. To be eligible, entrants must be subscribed to the Net-Work email newsletter at any time during the prize draw period.
4. Entry is free. No purchase is necessary.
5. Entrants must be aged 16 years or over at the time of entry.
6. Employees and officers of England Netball, or any companies within the same group, or any organisations professionally involved with the prize draw (or in each case their close relatives) are not eligible to enter.

23. The winner must confirm acceptance of their prize and provide any required delivery details within the timeframe specified in the notification email.
24. For transparency, England Netball may publish the winner's name on its website or social media channels. If a winner objects to this, they must notify England Netball when claiming the prize. In such circumstances, England Netball must still provide the information to the Advertising Standards Authority if requested.
