

Terms & Conditions – “It’s Giving...” Membership Prize Draw

This prize draw is promoted by England Netball, the All England Netball Association (“England Netball”, “we” or “us”), a company limited by guarantee (registered number 01698144) whose registered office is England Netball, SportPark, 3 Oakwood Drive, Loughborough, Leicestershire LE11 3QF.

Any references to “we”, “us” or “our” shall be taken as references to England Netball. Any references to “you” or “your” shall be taken as references to any applicant for the prize draw.

By entering the prize draw, you are deemed to accept the following terms:

The prize draw:

1. This prize draw opens at 00:00:00 BST on **1st August 2025** and closes at 23:59:59 BST on **1st October 2025**.
2. Entrants to this prize draw must be residents of the UK, the Channel Islands, or the Isle of Man, and have purchased a 2025-2026 England Netball membership by 17:00:00 BST on the **day prior to each weekly draw**.
3. This is a free prize draw open to 2025-2026 England Netball members. No additional purchase is necessary beyond membership to enter or win. Group memberships are not eligible.
4. Entrants must be aged 16 years or over. Junior members may be entered via their parent or legal guardian. Employees and officers of England Netball or any companies within the same group or any organisation professionally involved with the prize draw (or in each case, their close relatives) are not eligible to enter. Limit of one entry per person.
5. If for any reason a technical interruption, fault or site failure occurs when purchasing your membership online, England Netball does not take any responsibility for incomplete purchases and any incomplete purchases will not be considered valid for entry into the prize draw. England Netball accepts no responsibility for any purchases which are not completed for any reason.

How to enter:

6. To enter, you must:
 - a) become a 2025–2026 personal member of England Netball, and
 - b) complete the prize draw entry form (linked in your thank you email). You must submit your entry by the closing date and time outlined in clauses 1 and 2.

7. England Netball shall not be responsible for and shall not have to accept entries which are not submitted before the closing time or are illegible, incomplete, or corrupted. You must have a valid email address and phone number to claim a prize or surprise.

Choosing a Winner:

8. Each week, at least one winner will be randomly selected through a computer-generated process. A minimum of nine winners will be chosen across the full prize period.
9. Winners of the prize draw will be notified by email or using the other contact details provided to us within 14 days after the closing time for the prize draw. If a winner cannot be contacted or is not available within 7 days of being drawn, we reserve the right to select another winner from the valid/correct entries that were received.
10. The winner will be required to confirm acceptance of their prize within 7 days of having been notified. If a winner has not claimed their prize by the date specified, then the winner's prize will be forfeited, and we reserve the right to select another winner from the valid/correct entries that were received. Winners must have a valid email address and phone number to claim their prize.
11. For transparency we will generally publish the name of prize winners online and on social media. However, if you are a winner and you object to us doing this or would like us to reduce the amount of information we publish, then please let us know when claiming your prize. In such circumstances, England Netball must still provide the information and winning entry to the Advertising Standards Authority on request.

We may modify these terms and conditions as necessary, and any changes will be effective immediately upon posting on our website. 16. England Netball reserves the right to hold void, cancel, suspend, or amend the promotion where it becomes necessary to do so.
